Classifications paying (\$1.20) Dues, such dues are District Council 16 dues check-off of (.95) and Union Local 250 Dues of (.25)</p>												
<p>NOTE: The Employer shall pay to the ARCA/MCA Promotion Fund \$.31 per hour worked for all classifications under this Agreement. That amount, which will be included in the "Composite Rate" is to be sent to the Joint Trust Depository.</p>
